## **Attendance Policy**

Consistent attendance in class is required in order for your dancer to grow with the curriculum. If your dancer will miss a class you must notify the office and find a make-up class. Up to 6 make-up classes are allowed during the 38-week session. Make-ups cannot be carried over into different sessions or school years, and there is no refund or prorated tuition offered if a student misses a class. Please contact the office to schedule any make-up classes. All make up classes need to be taken before March 1, 2025.

#### Attire

Toddler/Little Dancer/Pre Ballet Levels – Light pink leotard, ballet pink tights and pink shoes. Hair should be in a ballet bun.

Beginning Ballet thru Ballet III Levels – Light blue leotard, ballet pink tights and pink shoes. Hair should be in a ballet bun.

Intermediate thru Advanced III Ballet Levels – Black leotard, ballet pink tights and pink shoes with hair in a neat ballet bun. Older students are allowed to wear black bike shorts as needed.

Jazz/Lyrical/Tap/Stretch/Conditioning – Ballet clothes, leggings or bike shorts with fitted t-shirts or tank tops. No jeans, jean shorts, or skirts allowed.

Hip Hop – Leggings or bike shorts with t-shirts or tank tops. Tennis shoes with white soles. No jeans, jean shorts, or skirts allowed.

## **Tuition Schedule**

We are only offering automatic billing with 9 full monthly payments (Sept-May) and a half month's payment for June this year. The first payment is due upon registration. Payments will be automatically charged to your card on the 1st of every month with the last payment made June 1, 2025. Tuition charged is non-refundable.

**Recital Fee:** Our annual Spring Recital is scheduled for Sunday June 8, 2025. There is a recital fee of \$125 for the first class and \$65 for each additional class. This includes two complimentary tickets to the performance. Participation in the Spring Recital for is for dancers in our Pre-Ballet level and higher. Costume fees will be charged between January 20, 2025 – January 31, 2025. **You must notify us by January 13, 2025 if your dancer is not participating in recital.** No refunds are given after January 13, 2025. We do not allow students to switch class days after March 1. Our teachers and students begin working on Spring Recital choreography at that time. Dances are created with the number of students in the class for formations, spacing, etc. Consistent attendance is required.

#### Disclaimer

This is a complete and irrevocable release and waiver of liability. Specifically, and without limitation, I, on behalf of myself, covenant not to sue the Released Parties for any alleged liabilities, claims or causes of action released hereunder.
- 4. In the event of an emergency, I authorize Released Parties to secure from any licensed hospital, physician and/or medical personnel any treatment deemed necessary for Student's and/or my immediate care and agree that I will be responsible for payment for any and all medical services rendered.
- 5. I certify that Student is in good health and sufficient physical condition to properly participate in fitness activities at Sterling Ballet Academy and that I am knowledgeable about the proper use of any equipment that the Student will use and the rules of any activities.
